### **Q&A**

Q: I was wondering if you knew of any examples where a college applied to the CCCCCO for an alternative calendar, and then it was rejected just because of the strictness of the application?

A: When applications have been submitted and if judged to be incomplete, they are returned to the originating district for more work.

Q: Are any of the 40 plus colleges in progress or in the process of doing a similar evaluation as we are? Of the ones that did seek a consultant, did any of them go through this process? How many of them decided not to compress their calendar?

A: Question to be answered at the next meeting.

Q: If we do recommend moving forward with a compressed calendar, then we go through the application and we get approved. What can we expect in terms of actually implementing?

A: If the application is submitted, the timing will be done in such a way that we will be ready for the move in the particular year it done.
