Chancellor Gerhard introduced Vice Chancellor Nicholas who gave the following presentation.

**TENTATIVE BUDGET OVERVIEW:**

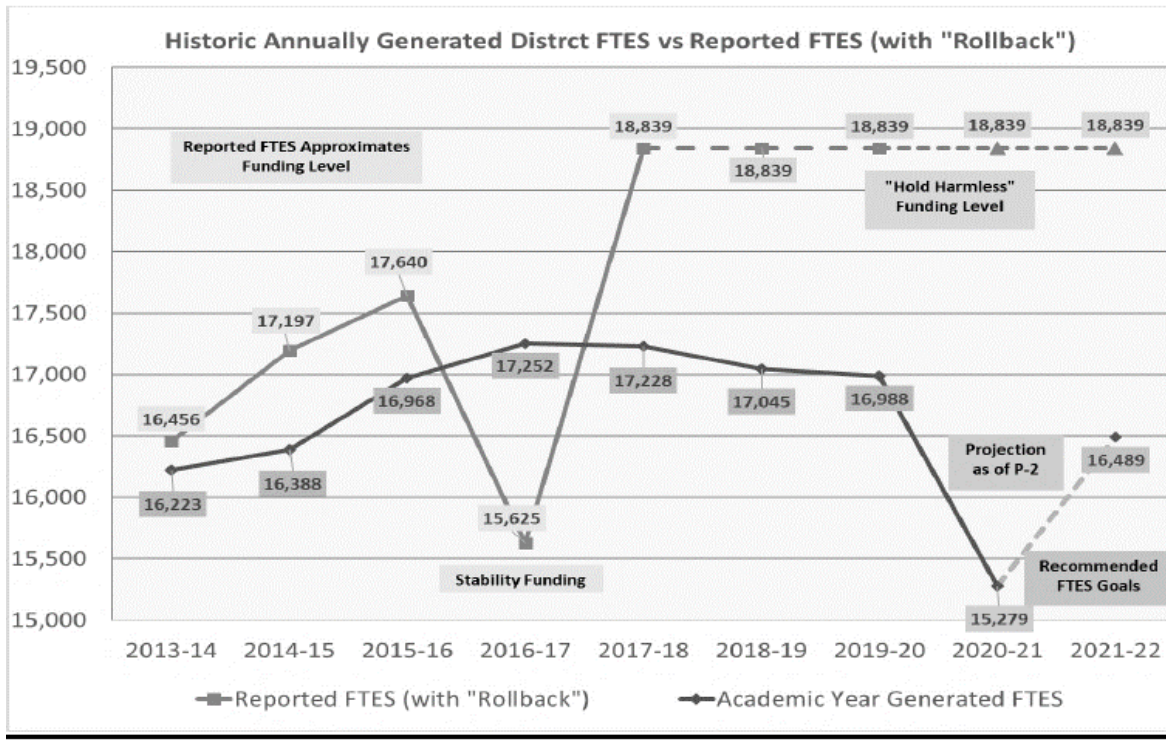
- Unrestricted fund is balanced districtwide
  - Surplus of approximately \$700k or about 0.6% of the expenditure budget
  - Surplus achieved through a combination of factors:
    - Unfilled vacancies
    - Reliance on federal stimulus dollars where appropriate
    - Hold harmless funding of \$8.8M
- Projected Ending Fund Balance of \$22.3M
  - Equates to a reserve level of 18.57%, well above the 8% target reserve in AP 6305
  - As we begin the FY 2020-21 closing process, this figure can and likely will shift, perhaps significantly, by the Adoption Budget

**MAJOR ASSUMPTIONS:**

- FTES Assumptions
  - Chabot College – 9,534 FTES; year-over year reduction of 668
  - Las Positas College – 6,955 FTES; year-over year reduction of 492
- Revenue Assumptions
  - COLA of 1.5% - Approximately \$1.7M in additional apportionment revenue
  - Enrollment Growth of 0%
- Expenditure Assumptions
  - Salary increase of 2%, approximately \$1.5M
  - Pension increases approximately \$630k



## **HOLD HARMLESS FUNDING**

- The unrestricted fund budget is balanced through the recording of the Hold Harmless revenue of \$8.8M
  - This is not distributed through the revenue allocation model
  - Results in negative reserves at the sites and a large districtwide reserve to counter those effects
  - Currently looking at resolving this reserve issue should the District migrate to a new Budget Allocation Model
- Hold Harmless funding is secure through fiscal year 2023-24

## **SIGNIFICANT CHANGES ANTICIPATED FOR ADOPTION BUDGET**

- Cost-of-Living-Adjustment (COLA)
  - FY 2020-21: 2.31% (previously was 0%; not included in current projections)
  - FY 2021-22: 1.70% (Tentative Budget projects 1.5%)
  - Compounded COLA of 4.05% over current levels
    - District Impact: An additional \$2.6M in apportionment revenue in FY 2020-21 and another \$2.0M in FY 2021-22. If enacted, this proposal would provide \$4.6M in additional apportionment revenue in FY 2021-22 over current year level.
    - Other Notable Items
  - Federal Stimulus funds; still have approximately \$24M of the \$30M in institutional aid remaining. May have a profound impact on year-end close.
  - State Unemployment Insurance rate will rise significantly year-over-year to the tune of an additional \$1M in fringe costs
  - New fund will be created based upon the establishment of an irrevocable trust

## **NEXT STEPS**

- Adoption Budget
  - Will incorporate the enacted state budget figures and will be presented to the Board prior to September 15<sup>th</sup>
  - As always, staff will continue to keep the Board apprised of any significant developments that occur between now and approval of the Adoption Budget

## Questions:

Trustee Gin thanked VC Nicholas for his detailed presentation. He asked if the negotiated commitments to our labor groups have been incorporated in this budget. VC Nicholas stated yes, the budget does anticipate the 2% salary increase that has been negotiated for fiscal year 2021-2022. He stated it is included within the academic and classified salaries and will trickle down into the fringe benefits as the 2% salary increases what we pay into FICA and unemployment insurance.

Trustee Heredia asked how long do we have to spend the federal stimulus funds and how much is remaining. VC Nicholas stated we were given one year to spend the first round of stimulus dollars however, it has been extended by an additional year with all indications being that another year of no cost extension out to 2023 will be provided. He stated \$6 million dollars out of the \$30 million in institutional aid was spent which leaves us with \$24 million dollars remaining.



Trustee Maduli stated his comments focus on the ending balance, particularly the unrestricted ending balance of \$22.3 million unrestricted funds. He stated he has concerns with the ending balance with Chabot's \$7 million and Las Positas \$1.8 million-dollar deficit. He stated five years ago Chabot's deficit was only \$4 million-dollars and now it is being increased to well over \$7 million dollars. He stated several years ago a plan was put in place to fix this however that has not come to fruition instead the deficit spending has been increased. He stated he has a question with regard to the allocation model and how that affects all of this and, at the very least he would like to see from both colleges a balanced budget for 2021-2022. He stated in-terms of the final expenditures that deficit has been increasing and cannot be fixed in one year. He stated he would like to hear from staff what the plan moving forward is so we could hold the colleges fiscally accountable and address this issue of deficit spending. VC Nicholas stated he likes to see balanced budgets as well. He stated the Planning Budget Committee, PBC meets twice a month and they go through an enormous amount of data, particularly data relevant to the SCFF and have made large strides when it comes to the revenue side of the model. He stated they are setting up models in which colleges are encouraged to balance their finances in a fiscally responsible way within the constraints of the figures and the funds they are provided on an annual basis.

VC Nicholas stated we are in a very unique timeframe to leverage some of these additional resources in order to get to a good starting place with a budget allocation model and are working towards balanced budgets at all sites.

Trustee Reynoso asked what is going on with the pension committees. VC Nicholas stated on the STRS side there will be a slight increase year over year as well as PERS. He stated both systems are underfunded, so I don't see the numbers on the pension side going down unless the state injects one-time money into those systems in order to buy the rates down.

Trustee Sbranti stated he thinks the approach about being cautious on the one-time dollars coming in makes sense, it is an infusion of money coming in but making sure we are not committing to long term expenditures for one-time dollars. He stated it is prudent that although we have tightened on the hiring that is not a strict across the board freeze; hiring needs to happen to fulfill our mission. He asked what extent are we making progress towards our District's long-term pension liabilities and where are we with the retiree benefits trust. VC Nicholas stated the pension costs itself, the budget certainly is reflective of the new higher rates. He stated with those higher rates there is still a small surplus. He stated there are some college districts that have taken advantage and try and prefund some of their pension liabilities but that has not occurred here. He stated getting dollars established and allocating funds for the post-employment benefits and irrevocable trust would be his first choice prior to doing any pension pre-funding. He stated the District has a substantial liability that will decrease enormously once this irremovable trust is established and money is put in because the actuary will be able to use a higher discount rate. He stated this will also allow us to start plugging away on what is the largest liability that is internally owned and specific to us, unlike CalPERS and CalSTRS whose underfunded status is owned by all its participants.

VC Nicholas stated the Board recently approved the composition of the retirement Board of Authority and Last week the investment policy statement was approved at the inaugural meeting.

President Randolph stated she appreciated Trustee Maduli bringing up the deficits at the colleges and also appreciated VC Nicholas replying that the Planning and Budget Committee, PBC we will be looking into this.

President Randolph asked Chancellor Gerhard to comment on the college's deficits. Chancellor Gerhard acknowledged the work at the colleges and President Sperling for cutting the deficit within three years by two thirds. He stated he understands it is a structural allocation model issue that he knows VC Nicholas is helping lead and facilitate that conversation at our PBC meetings so structurally this will not continue moving forward. He thanked everyone at the colleges that have made difficult decisions that impact programs and services to students to pay money back or fill that deficit. He stated he acknowledges this deficit and much work is left to be done and thanks everyone at the colleges that have had to make difficult decisions that impact programs and services to students to pay money back or fill the deficit.

President Randolph asked why the unemployment insurance rate has gone up. VC Nicholas stated the rate has been stuck at a minuscule rate since 2013-2014. He stated when COVID hit unemployment skyrocketed and the state adjusted its rates to meet the demands within the program.

President Randolph asked how much are we expected to receive from Hold Harmless Funding this year. VC Nicholas stated we are expecting approximately \$8.8 million dollars however, this depends on our FTES reporting. He added since the Hold Harmless has taken effect that number has fluctuated within a pretty small range from \$8 to \$10 million dollars. President Randolph asked how long will the state continue to provide this funding. VC Nicholas stated Hold Harmless will go away fiscal year 2024-2025.

President Randolph thanked Chancellor Gerhard, Mr. Fouquet, staff, District staff and colleges staff for the work they have done with the Hold Harmless funding and SCFF.

Trustee Heredia asked if we don't meet our enrollment goals will we still receive the same funding. VC Nicholas stated regardless if we reach 16,489 targets under the Hold Harmless provision the District will still be funded at that much higher level in the 18,000 range. Trustee Heredia stated it is her understanding when the Hold Harmless goes away that is when we will have an issue. VC Nicholas stated yes.

Trustee Reynoso asked what the plan is for the structural deficit. VC Nicholas stated he hoped to address some of that in terms of the work that is being done through the governance and Planning and Budget Committee. He stated the guidelines that are being formalized on the federal dollars will provide an opportunity to offshore up the deficits we are seeing at the site. He added, they are trying to address some of the structural issues at the site levels by looking at ways to perhaps funnel additional resources to them or look for the right sizing of the institution.

Chancellor Gerhard stated when this situation started to materialize three fiscal years ago, the Board asked for a plan overtime to address the deficit. He stated a five-year plan was presented and approved by the Board to pay back the deficit. He stated unfortunately COVID has slightly set us back but I believe we are in alignment. He stated the structural deficit has gone from \$2.7 million dollars to \$1.1 million dollars. He stated the deficit number will be much smaller once the audit is completed, books are closed and the 311 is presented to the Board.

VC Nicholas thanked the business office staff at both colleges and the business services staff at the District for all the work they put in . He gave a special thank you to Ms. Rosalie Roque, Ms. Joanne Bishop-Wilber and everyone who helped to put the book together.

President Randolph thanked everyone on behalf of the Board and appreciates the work they are doing.

  - 30.3% Strongly encourage
  - 7.7% Neither mandate nor strongly encourage

  - 44.1% No
- Are you willing to return to in-person teaching on campus if employee vaccinations are not required?
  - 53.5% Yes
  - 46.5% No

- Comments:
  - You cannot mandate a vaccine that has not been fully FDA approved,
  - If feel that mandating vaccinations for students may become a barrier to enrollment and degree completion,
  - Can we make vaccination available on campus over the summer?
  - It is irresponsible to come to campus without a vaccination and goes against our institutional outcome of civic responsibility
  - I know there is concern we may lose students if we mandate a vaccine, but consider that we may also lose students if we don't mandate a vaccine
  - When I chose "Mandate" it is with the understanding that this is to be in the classroom. Students can still take classes at Chabot, they would just have to be online
  - Many students are vaccine hesitant because of rampant misinformation. We cannot exclude these students. We need to be working with them
  - My answers will change in likely one more semester. People need time to adopt to and be ready to vaccinate. I think it should be strongly encouraged in fall 21 and then mandated in spring 22. I'm worried that by moving too quickly we will lose our most disenfranchised students, whereas if we gave them a little more time, we wouldn't lost them. We need to get to a mandate eventually, for me it's just a question of how can we get to a mandate leaving as few students behind as possible.

**Las Positas College Academic Senate President, Ms. Sarah Thompson provided the following report:**

For only the second time in my 7 years of serving as LPC's Academic Senate President, I am missing a board meeting as my youngest daughter is graduating from high school today. Please accept my apologies and my gratitude to Miguel Colon for delivering my report.

I am pleased to announce that the LPC Senate has, in conjunction with our Chabot College colleagues, ratified the District, College, and Senate level resolutions regarding the embracement of welcoming and celebrating practices to our LGBTQ+ students and staff. My senate is looking forward to working collaboratively next year with our Student Senate to intensify our culture of radical

hospitality by creating a space of gathering for our LGBTQ+ students. Special thanks go to Miguel Colon, Mona Abdoun, Ashley Young and Craig Kutil for their work on these resolutions.

My LPC colleague gave a public comment on an issue that has disturbed our Senate greatly, which is the suggestion made by Trustee Reynoso that we curtail our reports to fit into a preconceived notion of what was reasonable to him. He then went on to list a “timing” of the reports from the different constituencies. Our board meetings are actually the envy of many of colleagues across the state who report 4+ hours of board meetings. We average between 2-3 hours in our public sessions. But the length of our board meetings is irrelevant. I, too, sit on the board as an elected representative. As I receive reassigned time for my role, I, too, am technically paid to be here. So, Miguel and I actually fill similar roles as our elected, stipend, trustees. I stay for the entirety of board meetings because it is my job to do so. Every member of our community who reports out, whether it’s a Vice Chancellor giving an update, or our Presidents of our Classified Senates, work their tails off to give everything they can to our District. They deserve our time and attention so we can learn the happenings of our institution at all levels. Do they sometimes have longer reports than others? Yes. But I still listen, understanding that they are excited to share what they are doing – excited to share what is being accomplished. Critiquing their length of report is not only a violation of the Education Code, it is also demoralizing and has no place in our District Culture.

I am angry for my new Associated Students President, who came to his first meeting full of new ideas and ambitions to only be met with a critique of the length of his first Board Report. I realize that this was only the opinion of one Board Member, but I heard no rebuttal from any of the Trustees. I have assured Student President Johnson that we will defend his space to tell us all about what the students of Las Positas College are doing, because I was under the assumption that’s what we are all here for.

## **2.2 PRESIDENTS OF CHABOT AND LAS POSITAS COLLEGES AND DISTRICT CLASSIFIED SENATES**

### **Las Positas College Classified Senate President, Mr. David Rodriguez provided the following report:**

I can’t believe this is my last report as the LPC Classified Senate President. These past two years have been an honor. I appreciate the opportunity to share, advocate, and work together to strengthen our collective service to our students and community. Reflecting on the challenges and experience in this role, I found this quote from, John Lennon, very fitting:

*“There are two basic motivating forces: fear and love. When we are afraid, we pull back from life. When we are in love, we open to all that life has to offer with passion, excitement, and acceptance. We need to learn to love ourselves first, in all our glory and our imperfections. If we cannot love ourselves, we cannot fully open to our ability to love others or our potential to create. Evolution and all hopes for a better world rest in the fearlessness and open-hearted vision of people who embrace life.”* – John Lennon

- Follow the lead of our health experts.
  - We should respond responsibly, safely, in ways that extend trust and respect for our community members. Let’s check our fears.
  - We should proceed with caution. Mandating vaccines for students could:

- create access barriers among students most at need,
  - generate legal exposure, and
  - produce enforcement costs, with less flexibility than other institutions
- Alternately, we could strongly encourage vaccination and help educate our community, focusing our efforts on the main reasons for vaccine hesitation.
  - Listen, partner with health experts, and inform
- An ethic of love. Our excellence begins and ends with how we treat each other and address the issues.
  - About four years ago, Umoja and Puente students worked on an art project themed: One Love. I was reminded of the poster they created that conveyed unity, love, and embrace of our diverse community.
  - Umoja's Ethic of Love, is a "willingness to share ourselves, our stories, our lives, our experiences to humanize and make real the classroom." It encourages us to show compassion and care; and a warm community embrace.
  - Oftentimes our "higher-level" conversations tend toward the formal and procedural. Sometimes that is necessary, we deal with tough issues. But often, this leads us to become cold and adversarial. We end up posturing and maneuvering, reducing our problems to a zero-sum game. In the process, we can undermine our deepest values and reduce our ability to work together. I hope we continue to increase our institutional trust, improve our conversations, and clarify our direction. With courage, accountability, and compassion we have the potential to reduce friction and increase synergy. Our work allows individuals and families overcome difficult circumstances and reach up for something greater. It's tough work, but this is how we can love our community. By taking on these challenges, finding ways to work together, and treat each other well, we live up to some of our higher values. We are blessed with a lot of caring individuals who are passionate about our students and the work we do. My hope is that, in these institutional conversations, we look at ourselves honestly and find ways to bring out the best in each other, for our students and community.

**Chabot College Classified Senate President, Ms. Noell Adams provided the following report:**

**GOOD OF THE ORDER**

**Ms. Rachel Ugale, Chapter President SEIU, reported on the following:**

She recognized the amazing leadership and advocacy of our outgoing Las Positas Classified Senate Presidents Ms. Noell Adams and Mr. David Rodriguez. She stated they are leaving behind a collective body of work that highlights not only their individual achievements but that of the senate leadership. She stated as a classified professional she is grateful for all they have done to elevate our colleagues across the District.

She stated the leadership team is continuing to bargain a successor agreement to their COVID-19 that she hopes addresses a number of items. She stated although they do not have a signed letter as of yet, workers are starting to transition back to provide face-to-face services to students. She stated to many this is a time of uncertainty and anxiety however; they appreciate the flexibility managers have taken with concerns members have expressed. She thanked VC Letcher for continuing to do site walkthroughs with their unit members and SEIU leadership to address safety concerns.

Lastly, she stated she is looking forward to tomorrow's meeting with management to continue discussions and hopefully make progress towards an agreement.

**Mr. David Fouquet, President, Chabot-Las Positas Faculty Association, provided the following report:**

We were surprised to learn that the Association of Chief Business Officials (ACBO) has taken a position in opposition to the Legislature's proposed \$170 million in funding for full-time faculty hiring in their 2021-22 budget. Our understanding is that enrollment declines and the Full-Time Faculty Obligation Number (FON) are cited as reasons, although I must admit that I'm having a hard time understanding that rationale— considering that the point of the funding would be to drive the FON upward in such a way that the additional faculty are funded. As a quick and dirty calculation, our district's share of \$170M is about \$2.5M, which would fund twenty or so new full-time positions at our two colleges.

The Faculty Association of California Community Colleges, or FACCC, to which the FA is a contract member, and with which we have collaborated on SCFF advocacy, strongly disagrees with the ACBO position. As FACCC's Executive Director Evan Hawkins pointed out: "The fact that we have money proposed for the first time in a long time of the magnitude that is required to really be significant, and we're going to turn that down? That doesn't make any sense to me."

My own position is that insofar as we, as educators, seek to do serious work around optimizing student success, we need to embrace every opportunity to improve the proportion of our classes taught by full-time faculty.

VC Nicholas stated the Resolution is a not too exceed amount, market conditions will determine the amount that we actually go out for refunding. He stated we want to get the maximum of savings we can for the taxpayers which is why the ceiling is at 275.

Trustee Maduli stated he is happy to see the benefits from the refunding will be going back to the property owners in the District. He asked what the estimated savings that will accrue. VC Nicholas stated a refunding of 5% of net present value on the bonds, we are looking at being able to refund approximately \$172 million, with all of those achieving at least a 5% net present value savings. He stated this would provide present value savings of over \$21 million to the taxpayers and it would be 12.4% of net present value as a whole. Trustee Maduli asked when this will be addressed. VC Nicholas stated the refunding and an issuance of new money bonds in the month of July.

Trustee Reynoso asked what the contracts state. VC Nicholas stated there is some negative arbitrage that occurs. He stated we are issuing a new tranche of refunding bonds that retires and defuses. He stated there are several bonds out there in the three to four net present value savings that could get to the five percent by the time we go to market. Lastly, he stated if there is an opportunity to do a refunding on its own he has done those in the past but typically he likes to pair the refund with an issuance.

He stated the \$200 million is overlaid with a spin down schedule provided by the facilities department, based upon the construction projects that they anticipate to do in the next several months. He stated the \$200 million aligns with that spend down schedule and also aligns with the requirements that a certain percentage of these monies be spent within the three-year time.

Trustee Sbranti asked to speak regarding AP 5130, Financial Aid. He asked what the rationale was for the substantial additions to the original language. He also asked what the pathway is for student that have fallen out of eligibility for financial aid. Chancellor Gerhard stated many of the changes are requirements of accreditation standards have been updated as well as Title Five.

VP Kritscher stated students need to achieve satisfactory academic progress, above a 2.0 GPA and 67% completion rate. He stated their counselors are tirelessly working with students to get them in good standing to be eligible for the California Promise Grants. Trustee Heredia stated as a former counselor and department chair this helps student. VP Kritscher stated Academic Renewal is important for students and having the ability to have grades not count towards there GPA after petitioning for academic renewal and completion of the eligibility requirements.

President Foster stated when students are placed on probation there is an intervention with counselors. He stated there is language regarding extenuating circumstances and our students have the opportunity to talk about the challenges that they have experienced.


