Each college may not put more FTEF on schedule for Summer and Fall combined 2025, then was put on for Summer and Fall 2024. The colleges will have the flexibility to distribute the totals below.

Using the FTES count contained in the September 29, 2025 Argos report each college that is on pace to achieve the FTES target for 2025-26 will retain the remaining FTEF in their allocation for use in the Spring 2026 semester. Should either college not be on pace to achieve their 2025-26 FTES target, remaining allocation will be reduced for Spring 2026 as outlined below.

"On pace" means achieving or exceeding the Fall 2024 credit and noncredit combined FTES (Full-Time Equivalent Students) as of the same point in time, after census, and no later than September 30, 2025. The actual credit and noncredit combined FTES numbers for Fall 2025, as of September 29, 2025, will be compared to the DEMC dashboard report for credit and noncredit combined FTES from the corresponding week in Fall 2024 (specifically, September 30, 2024). Start dates for the fall semesters are fairly consistent, i.e. Monday, August 19, 2024 and Monday, August 18, 2025.

A reduction of 3.50% of the remaining allocation would take approximately 16.4 FTEF off the schedule for Spring 2026.
