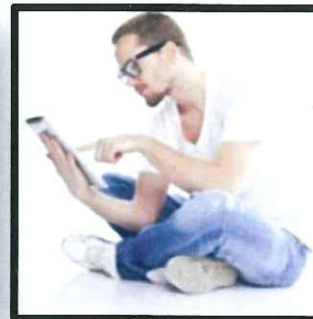
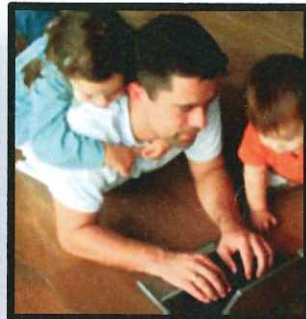

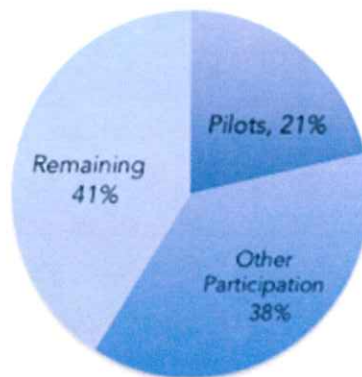
January 2014 to June 2015 Update

**2014-15 Overview:**

Since January of 2014, the OEI transitioned from a launch team to permanent leadership, developed quality online course design standards, reviewed over 80 online courses, completed the first OEI Pilots, which focused on Online Learner Readiness and Tutoring, selected a common course management system for the state (CCMS), and began implementing the CCMS. The OEI is improving DE in California.

To date over 75 colleges within the system have participated in some aspect of the initiative. Approximately 4000 students participated in Pilots in Spring and Fall 2015.

**Guiding Philosophy:**

**February Professional Development Summit:**

- 90 educators from the 24 pilot colleges attended
- 70 courses that were reviewed were addressed with instructional designers
- Workshops about accessibility, video production, effective teaching practices, online learner readiness and more!

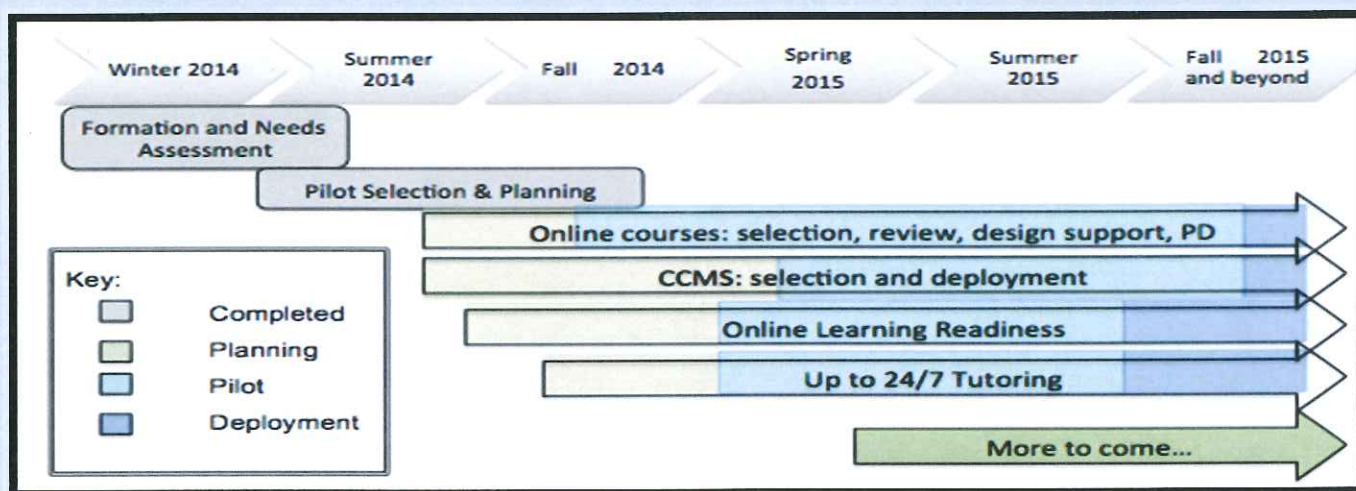

- Initial funding received December 2013
- Launch Team Hired January 2014
- **17 Associate Degrees for Transfer core courses are identified April 2014**
- Permanent Management Team Hired July 2014
- **Quality Course Standards Developed/Adopted August 2014**
- 58 Colleges Applied for the Pilots/24 Selected September 2014
- Course Review Process Developed September 2014
- CCMS Committee work begins October 2014
- **30 Course Reviewers Trained October 2014**
- **Online Learner Readiness Tools developed November 2014 Pilots begin January 2015-Revision completed and made available to all Calif. Community Colleges in Summer of 2015**
- **Link Systems Online Tutoring Platform and 24/7 tutoring selected November 2015**
- Access to Instructional Designers begins February 2014
- **Professional Development Summit held in February 2015**
- **Canvas selected as state-wide CMS February 2015**
- **Underprepared Students' Support activities begin Mar. 2015**
- **Reciprocity Agreements for OEI Course Exchange developed at summit in March 2015**
- Tutoring and Readiness Pilots completed phase 1 May 2015
- **CVC Catalog Refresh Completed June 2015**

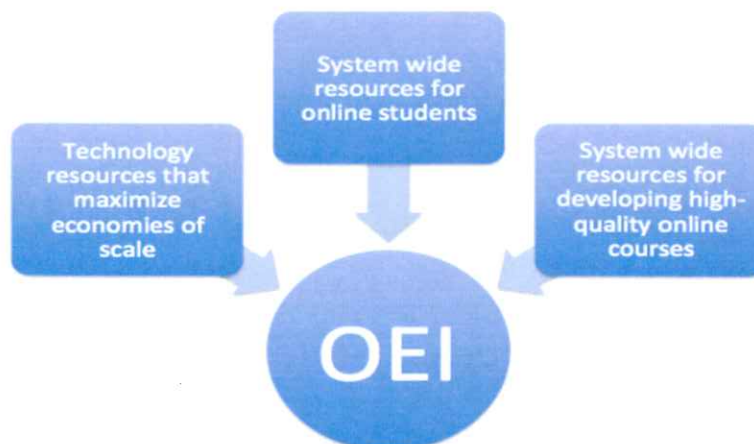


## Accomplishments continued....

- Implementation of Canvas Course Management System for pilot colleges began June 2015
- Online Teaching Conference with 700 on-site participants and over 200 online participants June 2015
- Faculty professional development networks begin Summer 2015
- Student Readiness solution revised from pilot data July 2015
- **Strategies development for under-represented students begins July 2015**
- Fall 2015 Phase 2 of pilot programs expands use of readiness and tutoring solutions and begins offering courses in Canvas
- 200 faculty are trained in the use of the OEI Course Design Rubric Summer 2015

## In Progress.....

- @ONE Certification Revision complete by Oct. 2015
- Clearinghouse for Professional Development in progress and scheduled for completion by Fall 2015
- RFP's for Academic Integrity Solutions and for Online Counseling Platform Oct. 2015
- Increased student access to bottle-neck courses via the OEI Course Exchange Fall 2016
- Full system Implementation of the OEI Course Exchange begins Fall 2017
- Canvas implementation continues with phased cohorts to 90 colleges by end of 2017
- Credit for Prior Learning Activities begin Spring 2017
